Subject Access Request, under the Data Protection Act 1998

I am responding to your subject access request for any personal data held on you by the Labour Party. My apologies for the slight delay in response caused by a slightly higher number of requests than usual combined with staff holidays.

The Labour Party is legally required to provide you with a description of:

The personal data;

The purposes for which it is processed; and

Those to whom it may be disclosed.

Please find enclosed all information that relates to you that is held by the Labour Party. The purpose is largely for communication which is self-explanatory.

Included is information stored on an electronic database that holds electoral register information that political parties are entitled to process for electoral purposes.

Finally, the enclosed documents were retrieved from the relevant databases/filing systems when a search was conducted on your name and/or address.

Personal information relating to third parties has been redacted except where it is clear that you would already be in possession of that information. Duplicate copies of information have, where possible, been removed for your convenience. I don't believe there is any material which requires further explanation.

None of this data would be disclosed outside of the Labour Party.



In Rushcliffe, I gather that an initial investigation may help to determine who was actually involved? Beyond the two main protagonists, would it be appropriate to identify who was involved and then issue them with an NEC warning? This initial investigation needs to happen from the regional office and not the regional board, for obvious reasons.

All 21 members involved in this have been written to so we can ascertain the relevant facts of the case before I can decide what action is appropriate.

More generally:

- For those awaiting outcomes from the council/police/court: Could you find out details of what stage these are at please? Some may have been dropped or convicted without us knowing.
- Those waiting for action from us: We need to get moving on these. Could you, or the relevant person in your team, please contact the suspended person to arrange an interview, and let me know what the arrangements are? If we are likely to be recommending that they be referred to a hearing of the NCC, I will need to report to the NEC in July. If we are likely to give them a warning, ideally I would like to do this before July so that they can come off the suspension list. If that isn't appropriate for whatever reason, could I have a paragraph on the situation so that I can speak to it, please? If it's an anti-semitism allegation, stand by for further advice from Compliance so that we can approach these consistently nationally. This will come later this week.

The papers for Disputes will be going out on 29th June. I will need a progress report well in advance of this.

A brief history to start with. There have been a few issues with Rushcliffe CLP in the previous few months – complaints around bullying, harassment, process etc have been flying around for some time, but without anything particularly firm for us to act upon.

With regards to the more serious allegations of bullying and intimidation the attached letter was sent to the protagonists, Peter Gates and [REDACTED].

To try and mediate a way forward for the CLP, and to provide the officers with some support, the Chair of the Regional Board agreed to attend a meeting of the CLP EC, inviting along Peter Gates and [REDACTED] who have both been the subject of complaints, and have made a number of complaints themselves.

In anticipation of the meeting, a number of queries were made by Peter Gates, which were answered by a member of the East Midlands team. The Regional Board Chair did not make contact with any of the parties, though it is my understanding that quite a few attempted to make contact with him, but he wished to avoid any view of former prejudice. Attached is the correspondence from both individuals with regards to the meeting.

The EC took place on Monday evening, and at the point when John and Peter were invited to join the meeting a number of uninvited members attempted to take over the meeting. The full details of what then took place is attached in the minutes from the CLP Secretary and the report from the Regional Board Chair (the latter report was submitted the same evening so I understand is lacking some of the names and precise timings).
